Overview



- The Advanced Reasoning and Analysis (ARA) workshop is an intensive three-day introduction to advanced concepts and skills of reasoning and argumentation.
- Participants are generally already proficient, and are seeking to take their understanding and performance to a new level.
- The ARA workshop uses software-supported argument mapping techniques and a very engaging case study.
- Austhink has delivered the ARA workshop many dozens of times, to organisations ranging from law firms and large corporations to intelligence agencies. The workshop is continually being refined.

The JFK Case Study


The workshop case study is the 1963 assassination of US President John F. Kennedy. We focus on the events in Dealey Plaza, and consider the arguments that there was a conspiracy.

Participants universally find the JFK case deeply engaging, and it provides excellent material for training in advanced reasoning and argument skills.

Austhink does not promote conspiracy theories. The conspiracy arguments fail, but this can only be properly demonstrated with rigorous analysis and attention to detail.



Workshop Content



- **Macrostructure:** assembling, organising and refining complex sets of arguments
- **Microstructure:** fine-grained analysis of reasoning, including exposing critical assumptions
- **Evaluation:** identifying strengths and weaknesses of individual inferences and complex cases
- **Argument mapping:** key concepts and techniques
- **Technical skills:** using argument mapping software

Participants will have improved general critical thinking skills. Specifically they will be:

- Better able to articulate and organize complex arguments
- Better able to identify strengths and weaknesses in reasoning

- Better able to lead and mentor others in rigorous reasoning and argumentation

- **Dr. Tim van Gelder** is a cognitive scientist with an international reputation for his work in critical thinking and reasoning skill acquisition. He pioneered the development of argument mapping and developed the software tools Rationale and bCisive.



- **Dr Paul Monk** is a widely recognised author and public intellectual. After gaining a PhD in international relations he worked for the Defense Intelligence Organisation, becoming head of China analysis. He has written many books and articles on a diverse array of topics, but with a focus on our thinking capacities.

Workshop Structure



Hands on

The workshop is conducted in a “hands-on” manner, using the bCisive software and numerous exercises, leaving participants able to apply their new knowledge and skills as soon as they return to their desks.

- The workshop is conducted in four sessions of approx. 90-105 minutes with breaks for morning tea, lunch, and afternoon tea.
- Generally the workshop runs from 9.00-5.00 three consecutive days. However alternative arrangements are possible.
- The workshop requires computers for participants and multimedia equipment (data projector, audio).


